This agreement shall apply to all boarding visits by your dog(s) to Dog Oasis, Dog Boarding, Pet Sitting and Training
Please sign at the bottom to indicate that you have read and understand

1. My dog(s) is in good health, is currently on all required vaccination for Canine Distemper, Parvo, Rabies, and Bordetella (Kennel Cough). Is free of fleas, ticks and lice and has not been ill within the last 30 days. My dogs' vaccinations have not lapsed and/or it has been more than 14 days since they have been vaccinated.
2. By Signing this agreement Dog Oasis has the owner's permission to treat a life-threatening condition or emergencies without owner's prior consent at the Owner's Expense. Dog Oasis will attempt to contact the owner's Vet first but owner agrees dog(s) may be taken to any vet available in case of an emergency at owner's expense.
3. RELEASE OF LIABILITY: Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries. Dog play is monitored by Dog Oasis staff to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner further understands and agrees that neither Dog Oasis nor any of its employees, staff, or volunteers will be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and Owner hereby releases Dog Oasis staff or volunteers of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending Dog Oasis.
4. Even with extreme caution some dogs can escape over or under fences or through latched gates. While your dog is boarding you may choose one of the following for his/her playtime. Your dog may be kept on a leash while at Dog Oasis fenced play yard, or your dog may exercise off a leash while in the fenced play yard. During drop off you have seen our fenced in area and would like your dog to **Exercise OFF leash in fenced yard** ___ **Exercise ON leash in fenced yard** ___
5. If you need to extend your dog's stay please keep in touch via text. We understand things happen and are more than happy to accommodate. Any dog not picked up within 5 days of scheduled pick-up date without communication from owner will be considered abandoned and will become property of Dog Oasis. We will attempt to contact your emergency contact at this point. Please ensure this information is up to date.
6. Required Informed Consent on Fire Safety. Dog Oasis Does not have a sprinkler system in the Dog Cabin. We have a wireless smoke detector that would alert us if smoke is detected. We have cameras that allow us to check in on the dogs when we are not in the Dog Cabin. Since we live on the premises 90% of the time there is someone on the property. There is an occasion when there is not someone on property. Under Texas Law we are required to inform you that your Dog(s) may be left unattended at times without a fire sprinkler system.

I have read the policies of Dog Oasis. I agree to pay for boarding and all charges for additional services or veterinary treatment that may become necessary during the time my pet is in the care of Dog Oasis. I represent that I am the legal owner of the above-named dog(s) and I assume all risks, dangers, and responsibility for injuries to the named dog(s). Furthermore, I agree to these policies and Hold Dog Oasis, Its Owners and employees free from any and all liability which I or my dog(s) may suffer including but not limited to injury, sickness, damage, or death resulting from participation in daycare and boarding. Furthermore, any controversy, claim or potential cause of action arising out of, or relating to this Agreement, or a breach thereof, by any party to this Agreement shall be subject to mandatory Arbitration in accordance with the rules of the American Arbitration Association, with the costs of such arbitration and reasonable attorney fees absorbed by the non-prevailing party.
